## How to Apply for a Visa (Non-American Passport Holders)

Check whether you require a visa to travel to the Republic of The Gambia or you belong to the visa waiver program countries, if you do need to apply for a Gambian visa and you are not an American citizen, please follow the steps below.

**Step 1** Visit the website <https://gambiaembassydc.gm/> and download the visa application form

**Step 2** Submit the passport with the visa application form to the Embassy of the Republic of The Gambia with the following:

- A nonrefundable application fee of \$100.00 in money order payable to the Embassy of The Gambia for regular visa processing fee. Three days express service fee is available for an additional fee of \$50.00 making it \$150.00.
- Same day service is also available for a fee of \$175.00
- Submit the passport to paste the visa on (valid passport)
- One passport-size photograph on white background (taken in the last six months; please write name and passport number at the back and sign)
- Prepaid self-addressed/return envelope (FedEx/UPS or Priority/Express Mail)
- Children under 18 years must submit a parental consent if unaccompanied by parents
- Personal or telephone interview may be required
- Application without the relevant requirements will not be considered

**Step 3** Processing of visa for regular services is between **5 – 10** business days. Three days express service is processed within **3** business days. In both cases, the processing period refers to the date the application is received between 10am and 12pm.
