**Note: Medical Report**

- All persons over 16 years of age intending to stay in Samoa for 1 year or more are required to produce medical reports. Your doctor must make his report on Form MPMC 102 for physical examination and blood tests, and MPMC 103 for the chest X-Ray which are available from Immigration Office and the Immigration website located at: [www.samoaimmigration.gov.ws](http://www.samoaimmigration.gov.ws)
- A medical report is not required if stay in Samoa is less than twelve (12) months (except for Food Handlers and Teachers)
- Those who have already undergone full medical checks in relation to their original permit may not require full medical examination but just a certification letter from a Medical Doctor or General Practitioner confirming good health status, is acceptable.

**Fee:**

- i* Conduct of business - \$900 for principal applicant if lodged outside Samoa, and if lodged in Samoa \$1,800 and \$450 for each dependent.
- ii* Employment - \$900 for principal applicant if lodged outside of Samoa and \$1,800 if lodged in Samoa and \$450 for each dependent.
- iii* Study - \$450 for principal applicant and \$200 for each dependent.
- iv* Research - \$1,200 for principal applicant and \$450 for each dependent.
- v* Cultural or Religion Purposes - \$300 for principal applicant and \$200 for dependent.
- vi* Family Reunion and Family Support - \$200 for principal applicant and \$100 for dependent.
- vii* Purpose approved by the Minister - \$300 for Principal Applicant and \$150 for dependent.
- viii* Visitor - \$200 per person.
