DECLARATION

I, the undersigned hereby apply for the issue of a permit and do hereby declare:-

- That I have not been previously removed or otherwise lawfully sent out of the Kingdom or any other country;
- That I have not been repatriated to the country of my nationality by the Government of Tonga;
- That I shall at all times whilst in the Kingdom have sufficient means of supporting myself and my family and (dependants), if any;
- I shall not become a pauper or a charge on the public;
- That I shall, if requested by an immigration officer, submit to an examination by a Government medical officer approved by the Principal Immigration Officer or undergo, or assist in the carrying out of, any test or investigation which such medical officer may require;
- That I do not suffer from a contagious or infectious disease which makes my presence in the Kingdom dangerous to the community;
- That I or any person included in this form has not been convicted by a court in any country outside the Kingdom of an offence which:
 - (i) is punishable by death or imprisonment for a term of not less than 2 years in the country of conviction
 - (ii) if committed within the Kingdom, would be punishable by death or imprisonment for a term of not less than 2 years.
- That I am under obligation to inform the Principal Immigration Officer or Immigration Officer of any change of status or address including any material change in circumstances that occurs after the application is made, if that fact or change in circumstances, may:
 - (i) Affect the decision on the application; or
 - (ii) Affect or alter the conditions of my original permit;
- That I am not a prostitute, nor a person who has lived on or received prior to entering the Kingdom, the proceeds of prostitution;
- If my permit is granted, I shall uphold and comply with any of the conditions and restrictions imposed thereon;
- If my permit is granted, I shall behave whilst in the Kingdom, in a manner that is conducive to peace, good order, good government and public morals;
- That if my permit is granted; I shall uphold all the laws currently in force in the Kingdom;
- The contents and information provided by me in this form and in all my attachments are complete, true and correct;
- That the Principal Immigration Officer is authorised to make any inquiries on me or any person included in this application, of any person who may be able to provide personal information or otherwise on matters which I have disclosed and which the Principal Immigration Officer may deem necessary in respect of information provided on this form in order to make a decision on this application.

I understand that failure to comply with any of the above declarations may (1) render any permit application to be refused or (2) where a permit has been granted, such permit shall be subject to cancellation or revocation and that I shall be removed from the Kingdom or prosecuted under the Immigration Act and subject to a term of imprisonment or fine or both.

NOTES

- General** This form may be used for application for any class of permit. You will also need to submit with this form the application fee and the information relating to the class and category of permit for which you are applying. This information is specified in a separate leaflet.
- Photographs** Two recent photographs (no more than one year old) of every person included in this application must be submitted with the application. The name of the person in the photograph must be written on the back of each photograph. The photographs must:
- show full face, head and shoulders only
 - be 40mm by 50mm in dimension
 - be printed on normal photographic paper
 - not include hats or sunglasses
 - not be mounted
- Section 1** Principal Applicant Indicate the class of permit you are applying for, and the category if appropriate (e.g. if you are applying to work in the Kingdom, you should apply for a class: temporary category employment*). Please Note that the Immigration Division is not currently issuing longterm or permanent residency permits as yet. We are awaiting new legislation.
- Section 2** Complete all of this section. Please submit your passport and any other documents required to establish your identity. If you hold passports from more than one country, give details for all of them.
- Section 3** Provide details of how you can be contacted.
- Section 4** If you are the principal applicant, and wish to include your family with your application add their details in this section. If there is insufficient space on this form, please submit the additional details on a second form or on a plain sheet of paper. Please provide marriage certificate if married and birth certificates for children.
- Section 5** If you are applying to stay in the Kingdom for more than 6 months, you will need to provide the names of two referees (and their contact addresses) who can attest to your character.
- Section 6** Please include an official Police Record for all persons on this form over the age of 18. If the Original Police Record is NOT in English, an English translation of the Police record must be included, which has been certified/authenticated by an official of the relevant Foreign Government and which bears the official government stamp of the relevant government.
- Section 7** The relevant medical form and the list of specified doctors may be collected from the Immigration Division, Ministry of Foreign Affairs, in Nuku'alofa.
- Section 8** If the application is for a child under the age of 18. Please complete this section if you are the legal guardian of the child or the parent in order to give your child permission to apply for the permit.
- Section 9** Everyone included in this application above the age of 18 must sign the declaration.
- Section 10** Indicate on the form the amount you have paid, and how you made the payment. Submit this form after completion and payment of the relevant fee:-
- (i) Submit all original documents; and
 - (ii) Copies of the original documents for certification by an immigration officer.
 - (iii) Include with this form all documents required for the category of permit for which you are applying eg. If you are applying for an employment category, submit your contract of employment etc. For documents required for each category, please ask the immigration officer for the list of conditions.

PLEASE NOTE THAT A VISITOR'S PERMIT IS NOT TRANSFERABLE TO ANY OTHER FORM OF PERMIT WHILST THE APPLICANT IS IN THE KINGDOM, UNLESS IMMIGRATION HAVE BEEN INFORMED OF THE APPLICANT'S INTENTION PRIOR TO HIS ARRIVAL IN THE KINGDOM AND IMMIGRATION HAS GRANTED PERMISSION FOR SUCH TRANSFERRAL.
